You must provide:</b></p> <ul style="list-style-type: none"> <li>• A tax filer who filed an income tax return with Guam, the Commonwealth of the Northern Mariana Islands, the Commonwealth of Puerto Rico and the U.S. Virgin Islands may provide a signed copy of his or her income tax return that was filed with the relevant tax authority. ### Step 3 – Financial Information - NONTAX FILERS
