

**SCHOLARSHIP ANNOUNCEMENT  
2021-22 ACADEMIC YEAR****TO INCOMING NEWSCHOOL STUDENTS:**

NewSchool of Architecture & Design awards the Dream Act Opportunity Award to outstanding students in all our degree programs who have significant financial need. Since undocumented students are not eligible for federal student aid, we have created this scholarship as an opportunity to ease the financial burden for Dreamers interested in attending NewSchool. Scholarship awards are made for up to \$10,000 per year and may be renewed each year until graduation. Scholarship funds are disbursed quarterly during the academic year.

**Minimum requirements:**

- GPA of 2.5 for undergraduates and 2.7 for graduates is normally required.
- A completed 2021-22 Dream Act Application with an expected family contribution number (EFC) below 10,000 is required. <https://dream.csac.ca.gov/>
- This scholarship may not be combined with other NewSchool scholarships or discounts except for the Community College Discount for Bachelor of Architecture and Bachelor of Construction Management programs.

**Deadlines:**

- Applications are reviewed on a rolling basis. Students must apply at least 1 week prior to their start date. Award notices are sent approximately 1 week after application is received.
