- Online Request - Go to [www.IRS.gov/transcript](http://www.IRS.gov/transcript), and then choose either "Get Transcript Online" or "Get Transcript by Mail." Get transcript online will give you instant delivery via PDF whereas get transcript by mail will mail you a copy to be received within 5-10 days. **Make sure to request a 2020 Verification of Non-Filing Letter.**
- Telephone Request - 1-800-908-9946, after following prompts, select option 2 to request an IRS Verification of Non-Filing Letter and then enter "2020."
